

Meeting of the Board of Directors June 23, 1956

A meeting of the Board of Directors was held at the Graystone Hotel. The following members of the Board were present: Willard Randolph, George H. May, D. C. Brandvold, William G. Akeley, Robert L. Bratt, William F. Hoganson, Bradley C. Marks and Carl J. Nedberge. The meeting was called to order by Willard Randolph, president. The reading of the minutes of the previous meeting were dispensed with by agreement of the Board. Mr. Carl Buck appeared on behalf of the Lake Sally-Melissa Association, for the purpose of soliciting membership into a Resort Group for the purpose of equalizing the taxes on lake property. A general discussion was had, after which George May made a motion that the Tax Committee take charge of the matter and that funds be paid them as needed, the Lake Detroiters Association to contribute their equal amount. This motion was seconded by Robert Bratt. Motion duly carried.

John Steinkopf, Becker County Sheriff, appeared at the request of the Board and after a general discussion as to the Small Boat Law and water craft regulation on Detroit lake, a motion was made by William Akeley, seconded by Robert Bratt, that Clem TeVogt be appointed a special deputy to assist the enforcement of water craft laws. Motion duly carried. Local and Fargo papers are to publish this information for the benefit of the public concerned.

On motion of Robert Bratt, seconded by William Hoganson the following bills were approved and ordered paid: Detroit Lakes Business College, \$4.05; Byron Allen Agency, \$17.10; Detroit Lakes Tribune, \$195.65. Motion carried.

There was then a general discussion as to having publicity of the Association in the papers for the purpose of letting the people know what the group is doing. A letter is to be sent out to all people on the lake telling them about the action taken in regard to the tax matter, spraying and try to encourage them to have membership in the organization. Copies of the bulletin were given to each member. A determined membership drive is to be started soon.

It was agreed to have the next board meeting July 7 at 12 noon at the Graystone Hotel.

The annual meeting of the Lake Detroiters Association was held at the Park Hotel August 18 at 2 p. m. There being a quorum present, George H. May, vice president, called the meeting to order. The minutes of the last annual meeting as well as the minutes of the meetings of the Board of Directors were read. There being no objections or corrections the minutes stand approved as read.

George May appointed the following to act as an auditing committee: William Akeley, Robert Bratt and Ed Cosgriff.

Dr. Tom Rogstad stated that this program has to be started early and that there has to be cooperation of all people on the lake before it can be made effective. It was also suggested that the members of this group have closer contact with the Board of Directors so that consideration can be given to all problems effecting the members of the Lake Detroiters Association. The Board of Directors is to meet August 25 at the Graystone Hotel at 2 p. m.

The meeting was then adjourned and coffee and doughnuts were served those present.

There was a general discussion as to the weed control in the lakes of Detroit as well as Sally and Melissa. Some of the members of the Lake Sally-Melissa group were present and it was agreed to attempt to get a Mr. Longtime to attend a meeting January 26 to discuss the weed control problem. A draft of a bill drawn by Henry Steining for the relief of taxes on lake property

was presented and discussed. A motion was made and seconded that the Tax Committee present this bill to the Legislature. Motion carried.

It was also agreed that an effort should be made to get the fish houses removed from the lakes before spring so that the debri would not float into shore and litter the beaches in the spring. The local papers are to be contacted and also the game wardens to see if this matter could be helped in any way.

A meeting of the Board of Directors was held at the Graystone Hotel at 12 o'clock noon with a luncheon. Members attending included: George May, Dr. Tom Rogstad, Fred Diles, Conrad Reitan, Marlow Baxter, Ed Nelson, Les Stolp, Wayne Lance, Mel Ulrich and Ed Longtime, Dr. E. L. Browe and Clayton Hamilton of Minneapolis, water weed experts. The plan which this group has for killing water weeds was discussed at length and also the cost. It was agreed that the weed condition in Detroit, Sally and Melissa lakes has reached a serious stage and that something will have to be done to kill these weeds. Mr. Hamilton and Mr. Longtime both explained in detail their method of spraying for weeds and the types of chemical used. They also stated that they had very good success last year in some of the lakes that they treated. A motion was made by Fred Diles, seconded by Conrad Reitan that the Association accept their program for killing weeds in Detroit lake and that the price to the propery owners and members of the Association be 15c per foot and to non-members 20c per foot. Motion carried. Dr. Tom Rogstad and his committee will handle this project and it is hoped that all members will lend a hand in helping to make this a complete job around the lake. Notice will be sent to all members and nonmembers around the lake. There being nothing further the meeting was adjourned.

Tax Committee Report . . .

The Tax Committee of your Association has been active in helping to present a bill to the Legislature in which lake cottages would be benefited. This bill has been introduced in the Legislature amending Sections 273.13 and 127.05. If this law is adopted, lake cottages would be benefitted by the inclusion of language in each of the sections by inserting the words "all real estate devoted to temporary seasonal or recreational occupancy but not devoted to commerical

use." It is felt that this language would bring about a new classification of real estate used for

summer cottages.

The bill is being backed by various associations throughout the state. If the bill passes, there would be new valuation of lake shore property as of 1957 and would be reflected in the amount of taxes to be paid in 1958.

Water Level, Weeds And Algae Control Report of Committee

Past results of our weed spraying have been gratifying to some of our residents, and extremely disappointing to others. There are some areas where it has done a very good job, and other areas where very few results were attained.

Your Committee has tried to find another solution to our problems, and we have contacted Dr. Lloyd Smith, Professor of the Department of Etomology and Economic Zoology at the University of Minnesota. Here is his reply

to our inquiries:

"Weed control is an annual affair at least for two or three successive applications. Then sometimes a measure of control is attained without additional spraying. Sodium arsenite is the commonest material used and when properly applied is very effective."

We also wrote to the Supervisor of the Biological Services, Bureau of Research and Planning, Department of Conservation, State of Minnesota, Mr. Bernard R. Jones. Here is his reply, in part: "Spraying with sodium arsenite

"Spraying with sodium arsenite still appears to be the most effective method for control of submerged aquatic plants, and sodium arsenite is recommended for general use."

So now we know that in the past years we have used the most effective means known against

our lake weeds.

The Committee feels that the one possible fault with our previous treatments has been the time of spraying. In years past, we have had to set an arbitrary date rather than spray when the conditions were most favorable. This was due to the fact that the only aquatic weed sprayer was based in Wisconsin.

This year we have been in contact with Messrs. Clayton Hamilton and Edward Longtime, who were recommended by Mr. Jones. Mr. Longtime is well-qualified, is a graduate biologist, and has served several years with the Department of Conservation, State of Minnesota. They will be based at Staples, Minnesota.

They have made us an offer where we can spray at a considerably lower rate than we have ever had before. From our preliminary negotiations with Messrs. Hamilton and Longtime, we can

spray at a cost of 15c per front foot for Association members and 20c per front foot for non-members. This spraying will extend out approximately 200 feet, depending on the depth of the water. They will take care of all loading and unloading of chemicals, warning signs and patrols. They will keep close check on the growth of our weeds so that the spraying can be done at just the right time. They will also give us a partial guarantee on the success of the operation.

As in any operation of this magnitude there are many problems. First, we must have a permit from the State of Minnesota to cover every area that is sprayed. Secondly, we must have large enough areas of lakeshore so that we can get our best results. In other words, there is no use to spray a lot here, and a lot there, or every other lot; we should have a continuous strip of at least 500 feet at a minimum, otherwise our chemical is disapated and lost. To achieve this, your Committee will have to rely on the residents to line up their neighbors so as to give us this minimum frontage.
