- Use easements that exist, bury cables.
- Was originally a state highway.
- Discussion regarding semi-trailers using this road to avoid the roundabout.
- Planned start date: 2020

• City asking for LDA support. Board thought the nature of the project is too vague at this time. Barb and Dick will draft a letter.

## **Ordinance Committee - dick Hecock**

- Goal: to increase shoreline protection start in 2020
- Impact zones structure limitations
- Vegetation removal plans
- Docking is one issue that may be taken up later.
- Avoid descrepencies in allowing variances.
